Terms and Conditions

2. I agree to comply with the following stipulations when I receive the distribution service of cell lines from the Japanese Collection of Research Bioresources (henceforth abbreviated as JCRB).

- 1) I fully respect the priority of the person who established the cell lines and comply with any limitations proposed on its use.
- 2) I will not use the cell lines in unethical experiments.
- 3) I will not use the cell lines to administrate directly to humans.
- 4) I will not use the cell lines to the making of individuals and germ cells.
- 5) I will use the cell lines only for research, testing, and educational purposes, and not for military and direct profit-making purposes.
- 6) I will not impart the cell lines to a third party.
- 7) I will not ask JCRB to be responsible for any accident or loss incurred from the use of the cell lines.
- 8) When I publish any results obtained from the use of the cell lines, I will state the registered number, name, and the establisher (or reference) of the cell lines along with the name of this bank as the source.



In Section 2. 5) "direct profit-making purposes"

1. The service-for-fee activities of contract research organizations (CROs) are regarded as "direct profit-making purposes".
2. Therefore, the cell lines should be purchased by end users who will entrust the CROs for their researches. If so, please fill in the end user's name and information as the applicant, then have him/her sign the Form A. This end-user's information doesn't restrict the shipping address and the billing address.

In Section 2. 6) "third party"

1. The phrase "third party" does not include end users' affiliates, collaborators for collaborative researches, or contract research organizations (CROs) under end users' supervision and control. In this case, affiliates, collaborators, or CROs should not use the cell lines for any purpose other than conducting end-user research.
2. Soon after the contract / collaborative researches are completed, the contract / collaborative research parties shall discard the cell lines or shall return the cell lines to the end user.
